From the Chair

The program for the April meeting promises to be as exciting as our October meeting. It has variety. It is informative. And it is taking place in an interesting place, River Park Center in Owensboro.

A central thread for the program will be some very practical issues that archivists must consider. There will be a panel discussion on collection development that will include Sue Lynn Stone, Dr. James Goode, Professor of English at Lexington Community College, and Martina Kunneke of the Kentucky African-American Heritage Center in Louisville. Jeanne Suchanek and Marie Ward, of the University of Kentucky will give us hints about fund raising for archival organizations. And Tom Rosko and Whitney Baker will talk about salvaging records after disasters, using the fire that damaged the University of Kentucky Administration Building as a case study.

As a sidelight, Joseph Ford will speak about historical anecdotes of Owensboro and Daviess County after lunch. Speaking of lunch, it will be catered by the famous Moonlite Barbeque Inn.

We will also need to conduct some business in April. New members of

the board need to be elected. The terms of Jeff Suchanek and myself are ending, and Craig Heuser resigned after leaving the Filson Club to teach. A slate will be presented at the business meeting.

Another item on the business agenda is an amendment to the KCA constitution. A suggestion was made at our last board meeting that it would smooth leadership transition if we had a chairperson-elect. An amendment creating the position will be offered for consideration. It amends section nine of the constitution and reads:

“The Administrative Board shall select from among its members a chairperson and *chairperson-elect*. The chairperson shall conduct the meetings of the Administrative Board and generally coordinate the activities of the organization. The chairperson shall conduct the business meetings of the organization and shall serve as an ex-officio member of the Administrative Board in the year following his or her term. *The chairperson-elect shall assume the duties of the chairperson the next year after the incumbent’s term ends, and whenever the chairperson is unable to perform the duties of the office.*”

From Audobon Parkway – Exit left (Owensboro exit) onto US 60 by-pass. Turn right at end of by-pass onto Highway 60 W (4th Street). Follow 4th Street to Daviess Street and turn left to 2nd Street.
